





Conecuh County Agriculture, Forestry, and Related Industries

Total Impacts: \$238.6 Million and 2,258 Jobs



Total Production

In 2010, \$61.3 million was generated through the county's agricultural and forestry production sector.



Cattle was the largest agricultural commodity, contributing 6.6 percent of the county's total agricultural and forestry production.

The second largest was cotton, which contributed 2.1 percent of the county's total agricultural and forestry production.

The third largest was greenhouse, nursery, and floriculture production, which contributed 1.1 percent of the county's total agricultural and forestry production.

Forestry Production

Timberland accounted for 81.4 percent of the surface land area of the county.

Total forestry production contributed 81.1 percent of the county's total agricultural and forestry production.

Overall Contributions to Conecuh County

Conecuh County's agricultural, forestry, and related industries generated 2,258 full- and part-time jobs, representing 47.0 percent of the county's total workforce (4,801 jobs).

The total impact of agriculture, forestry, and related industries was \$238.6 million, which was 35.8 percent of the county's total economic activity (\$667.0 million). The indirect business taxes impact was \$6.4 million, 36.3 percent of the county's total indirect business taxes.
